Country Specific Information for Prospective Adoptive Parents

Intercountry adoption is a child led service. Placing of the children will be determined by the matching criteria in applicants' homestudy reports. Waiting times are therefore not predictable for any programme.

- The age of children placed is determined by the age of approval on the applicants Article 15 Declaration of Eligibility and Suitability. Children up to the 14 years are available for intercountry adoption in all country programmes. The lower age profile of available children is rising in almost all countries
- Selection of Gender is not recommended and the referral of a child of either gender then applies to the application.
- Siblings are only available [other than twins] in some country programmes. An applicant would have to have specific approval for siblings or twins, and the age of child approval needs to be sufficiently wide to be suitable for siblings.

Costs in countries that place children for intercountry adoption are outside of the control of the Adoption Authority or of HHAMA. Fee schedules indicate the approved costs and there are additional cost factors such as flights to and from the country and logistics during the adoption trips.

All countries can require more paperwork, updated paperwork and translated paperwork. It is the applicants' responsibility to comply with any request from a donor country authority or nominated agency.

As the accredited body facilitating most intercountry adoptions, HHAMA requires that

- all applicants attend a pre-registration meeting before country programme selection to ensure all matters of eligibility and suitability are reviewed and found to be appropriate for the chosen country programme.
- all applicants submit a HHAMA additional needs checklist and allied care plan before HHAMA can finalise a country programme recommendation. Following approval, HHAMA also requires a copy of the Article 15 and the homestudy assessment report to formalise the request to join the waiting list for invitation to register, subject to the country programme parameters.
- > discussion of applicants' medical history is necessary to ensure suitability and compliance with the chosen country's criteria.
- > charges are made for translation of post placement reports
